## Safety Requires Teamwork





### Life Safety is always Priority #1



## **Church Self-Inspection**

- Keep Watch for Hazards
- Appoint Church Safety Team
- Perform annual Self-Inspection
- Invite Others:
  - Deacons, Teachers & Parents
- Take all Inspections Seriously
  - Self-Inspection Findings
  - Insurance Reports
  - Fire Marshall & Health Department
- Take Corrective Actions
- Perform Regular Maintenance





## Responding to Accidents



#### Promptly Report All Accidents





Provide First Aid or Call 911 for Emergency Help

### Report within 24 Hours



Report in accordance with Conference's HR Guidelines



## Cal/OHSA Mandates



#### All employers must have an Injury & Illness Prevention Plan on site at each location

The local supervisor (pastor) is the primary person responsible for safety at each location

# **Timely Cooperation**

- Promptly report all work-related claims (even minor accidents)
- Cooperate with Conference Workers' Compensation investigators, claims personnel and legal counsel
- Promptly respond to requests for accident or claimant information and necessary payroll earnings data
- If in doubt, seek counsel from Conference Human Resources Department

# Cal/OHSA Reporting

All Employers must report Fatalities within 8 hours and Serious work-related injuries or illness within 24 hours to Cal/OSHA by phone or fax — Report to SECC Conference Office

Serious Injury or Illness means:

"A fatality; serious injury or illness is that requires an employee's hospitalization for more than 24 hours for other than medical observation, or in which a part of the body is lost or permanent disfigurement occurs."

OSHA Part 1904.39(A)





# Key Safety Principles

- **1.Always provide First Aid or call 911**
- 2. Promptly Report all Accidents 24 Hours
- **3. Cooperate with Authorities and Conference**
- 4. Have a Church Safety Team and Conduct Self-Inspections of your Facilities
- 5. Keep Alert and Correct Un-safe or Hazardous Conditions
- 6. Develop and Implement an Emergency Plan
- 7. Use Licensed Contractors with proper insurance coverage
- 8. Volunteer Safety is the same as Employees
